The Zoom video conference was called to order by Commissioner Farkas at 7:00 pm.

Commissioner Farkas explained that the purpose of this meeting is to begin to come up with a list of procedures and protocols to re-open the pool with the ultimate decision to open to rest with the Board of Trustees. He reminded the Commission that there are 5 basic premises for practical, safe procedures that are being used when any of the Village's facilities have re-opened and should be applied to the pool also.

1. Always wear a mask from and when returning to the parking lot
2. Always practice safe social distancing
3. Always wear a mask when social distancing is not possible
4. When at the park, park in upper lot only
5. Arrive 15 minutes prior to your expected arrival

A discussion ensued on a number of concepts and ideas including admission process, daily capacity, fees, limiting pool facility amenities, staffing/training and safety protocols for both members and staff.

Commissioner Farkas assigned Suzanne Browar, Kara Mindel and Joan Levine to work on a draft letter to the residents outlining the pool protocols.

Commissioner Farkas invited those that are interested to join him tomorrow morning to walk the pool area to try to estimate the maximum capacity.

The Zoom video conference was adjourned at 9:30 pm.
